CERTI-VEX RUSTREMOVER quickly and effectively removes rust from steel forms and equipment. The product will also remove rust stains on concrete.

APPLICATION

- Spray Certi-Vex Concrete Rust Remover full strength directly on to the rust stain.
- Allow to soak for 1 to 3 minutes.
- Re-spray and agitate with a non-metal brush, abrasive pad or rag. For small areas, blot off rust with an absorbent towel or rag.
- Re-apply and agitate again as needed.
- Rinse area with clean water and neutralize with **StarSeal® EF Neutralizing Rinse & Cleaner**.

HEALTH AND SAFETY

- Use only with adequate ventilation.
 - Use of gloves, goggles and other protective clothing is advised when using this product.
 - If swallowed, do not induce vomiting.
- This product is acidic. Concentrate has a pH of 3. It will redden (not burn) the skin and is a contact irritant to the eyes. - Shelf Life: If properly stored in its original sealed container, three years from date of manufacture. May require mixing. Rotate your stock.
- Storage/ Handling: Store in tightly sealed original factory container. Keep from freezing and exposure to moisture. Store at room temperature prior to use. Care should be taken to keep dirt, water and contaminants away from the opening of containers.
- Delivery: Deliver materials to site in manufacturer's original, unopened containers and packaging, with labels clearly identifying product name and manufacturer.
